



Supplementary Figure 1. Cumulative analyses for VDBP gene rs7041 polymorphism associated with COPD risk.


(A) Allele model (G vs T)


(B) Heterozygous genotype model (GT vs TT)






(C) Homozygous genotype model (GG vs TT) (D) Dominant model (GT plus GG vs TT)






Supplementary Figure 2. Sensitivity analyses for VDBP gene rs7041 polymorphism associated with COPD risk.
