In the original article, there was a mistake in naming the new genus. The new genus established in the published article, *Foissnerella* Ma et al., 2021, is a junior primary homonym of *Foissnerella* Jankowski, 1986 that belongs to Epistylididae Kahl, 1933. According to article 57.2 of the ICZN (1999), the junior primary homonym, *Foissnerella* Ma et al., 2021, is permanently invalid. It is replaced by *Paratrachelocerca* nom. nov. Therefore, the *Foissnerella typica* Ma et al., 2021 is invalid too, and replaced with *Paratrachelocerca typica* nom. nov. The following corrections have been made:
