In the published article, there was a statistical error. The sample sizes was described as "We drew on summary statistics for critically ill COVID-19 cases and hospitalized COVID-19 cases from release five (https://www.covid19hg.org/results/r5/) of the COVID-19 Host Genetics Initiative Genome-Wide Association Study, which contained 5,101 critically ill COVID-19 cases and 1,383,241 controls (leave out study: 23andMe) and 9,986 hospitalized COVID-19 cases and 1,877,672 controls (leave out study: 23andMe) (Table 1)."

A correction has been made to Methods, "COVID-19," Paragraph 1.

The corrected sentence appears below:

"We drew on summary statistics for critically ill COVID-19 cases and hospitalized COVID-19 cases from release five (https://www.covid19hg.org/results/r5/) of the COVID-19 Host Genetics Initiative Genome-Wide Association Study, which contained 4,606 critically ill COVID-19 cases and 702,801 controls (leave out study: 23andMe) and 9,373 hospitalized COVID-19 cases and 1,197,256 controls (leave out study: 23andMe) (Table 1)."

In the published article, there was an error in Table 1 as published. The sample size of critically ill COVID-19 and hospitalized COVID-19 was incorrect. The corrected Table 1 and its caption appear below.
